

OFFICIAL RULES FOR "COUNTRY THUNDER GIVEAWAY" SWEEPSTAKES. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

- 1. ELIGIBILITY: In order to be eligible to participate in the "COUNTRY THUNDER GIVEAWAY" ("Sweepstakes"), each entrant must be 18 years of age or older as of the start date, and a legal resident of the United States. Proof of eligibility will be required.
